5. Recommended to use together with Safe Click [35560], Bio Clean Sponge [25240], Pro Razor [35563].

NOTE! Sensitive surfaces and surfaces that cannot handle low PH-values can get damaged like granite, marble, stones etc. Always test the surfaces durability before use.

Avoid storage < 0°C.

Be careful when used on paint, plastic surface.

Always test paint/surface stability prior to use.
